NOMINATION FORM

NEW ZEALAND PREMIER YEARLING SALE

I/We wish to nominate the horse/s listed on the reverse for selection to the 2018 NZ Premier Yearling Sale to be held in Christchurch on 13 & 14 February, 2018. PGG Wrightson Limited (PGW) reserves the right to transfer the dates and venues should the need arise and shall not be responsible for any costs incurred.

I/We understand the horse/s will be sold under the Conditions of Sale in the Sale Catalogue, the following Conditions of Nomination and Entry and to the extent deemed relevant by PGW, PGW's terms of sale (www.pgwrightson.co.nz/our-company/terms-and-conditions) as varied from time to time.

1. Reserve Cards are mandatory. Vendors must advise the Auctioneer in writing of their reserve price before the Lot is offered. Where no reserve card is provided the horse may be sold to the highest bidder, regardless of price and the Vendor shall pay 10% commission. The Auctioneer shall have the right to bid as agent on behalf of the Vendor up to the reserve. No Vendor shall bid or allow an agent other than the Auctioneer to bid on his behalf. This restriction does not extend to the dissolution of a joint ownership or syndicate. In the event of improper bidding by or on behalf of a Vendor, full commission will be charged and the Vendor shall accept the return of any Lot and all costs incurred should the sale of the horse be rescinded. The Vendor acknowledges and accepts that PGW may bid on behalf of any person from whom it has instructions so to do.
2. Entries must be on the official nomination form, please forward to PGW by 1 August 2017. PGW reserves the right to inspect entries and to accept, transfer or reject any entry, or to accept any nomination after the closing date. Horses bred by embryo transfer will be noted as such in the catalogue.
3. The Entry Fee for each Lot of \$603.75 (\$525 plus \$78.75 GST) or \$316.25 (\$275 plus \$41.25 GST) for the Supplementary Session is payable on invoice. This covers cataloguing, general sale advertising, venue hire and inward buyer scheme. Entry Fees unpaid as at 1st October 2017 will be charged interest from that date at a rate of 21 percent per annum.
4. PGW in selling any horse acts in all respects only as the agent for the vendor, gives no representation or warranty that any purchaser will complete his purchase or shall be under any liability to the Vendor in respect of any purchaser's failure to complete his purchase within the Conditions of Sale.
5. All horses shall be at the risk and expense in all respects of the Vendor until the horse is sold and the purchaser has assumed responsibility.
6. A refund of \$200 (plus GST) and \$100 (plus GST) (Supplementary) will be made on horses withdrawn through injury or accident after the catalogue has gone to print on October 25th, 2017. Refunds will be subject to an independent veterinary certificate at the cost of the Vendor.
7. All horses offered in this sale are sold subject to Goods and Service Tax. All bidding will be on a GST exclusive basis. GST will be added to the bid price and to all sale charges and commissions. GST collected on behalf of non-registered vendors will be paid directly to the IRD.
8. The Commission payable by the Vendor to PGW in respect of the sale price of each horse sold will be 10 percent whether by auction or privately at any time between the time of entry and 30 days after the sale, notwithstanding that the horse may have been withdrawn from the sale after the acceptance of the entry. Full commission of 10 percent will be charged on the last vendor bid amount of any unsold Lot for whom the Vendor/Purchaser Nomination Fee to the NZ Yearling Sales Series No. 28 is fully payable. An offering fee of 2.5 percent of the Reserve price will be charged on lots unsold for whom the Purchaser Nomination Fee to the NZ Yearling Sales Series No. 28 is not payable.
9. No horse entered for the sale is to be sold by the owner privately before the sale.
10. All yearlings may be examined by a representative of the Auctioneers before or on Sale day. PGW reserves the right to cancel an entry at any time. In any such case the entry fee or part thereof will be refunded and the Vendor shall have no further rights or claims against PGW.
11. The Vendor warrants and guarantees to PGW that he is the true owner of the horse or is duly authorised to sell the horse on the owner's behalf and that he is able to transfer good and unencumbered title in the horse.
12. The Vendor authorises PGW to accept rescission of any sale, allow any purchaser an extension of time for payment or agree to any variation of the Conditions of Sale, on behalf of the Vendor if PGW in its discretion decides that any such rescission, extension or variation is justified.
13. The Vendor indemnifies PGW against all loss, damage, cost and expense incurred by PGW as a result of the Vendor or Purchaser failing to comply with the Conditions of Nomination and Entry or the Conditions of Sale or as a result of any injury to or damage or injury caused by the Vendors horse.
14. No horse entered for the sale shall be broken in to sulky, cart or hobbles prior to the sale.
15. All horses nominated and accepted for the 2018 New Zealand Premier Yearling Sale including the Premier Trotters Session are automatically nominated for the New Zealand Yearling Sales Race Series No. 28 and the Vendor agrees to be bound by the conditions pertaining. The Vendor Sales Race Series Nomination Fee of \$402.50 (\$350.00 plus \$52.50 GST) per horse may be deducted from the Vendors sale proceeds by PGW and paid to the NZ Sires Stakes Board. Any horse nominated for the Sale and transferred to the Supplementary Session will have optional entry to and be subject to the Conditions of the NZYSS #28 pertaining.
16. Where PGW's services are supplied and acquired for business/trade purposes, the parties agree to contract out of the Consumer Guarantees Act 1993 and that it is fair and reasonable to do so.
17. The Vendor agrees to allow the Purchaser of the lot to arrange for an endoscopic examination of the horse to be carried out in accordance with the Conditions of Sale as printed in the relevant Sale Catalogue. The Vendor acknowledges that the Auctioneer shall not be responsible for or have any liability for damage, injury or illness suffered by the horse during or as a result of such examination. The Veterinary surgeon carrying out the examination acts as agent for the Purchaser not the Auctioneer.
18. Disclosure of Drugs and Blood Testing – The use of Anabolic Andronic Steroids in Standardbred's is banned. The Vendor authorises PGW, HRNZ, or the RIU and their approved veterinarians to take a blood sample from any Lot entered in the sale for testing. Within 60 minutes of the end of the sale or of the after sale of a Lot, the purchaser may request, at their risk and prior to the horse leaving the grounds, for a blood sample to be taken by PGW's Veterinarian for testing for Anabolic Steroids and other banned substances. Should the sample prove positive the sale will be cancelled and neither the Vendor nor Purchaser will have any claim against each other or against PGW. The Vendor is responsible for the cost of return of the Lot. The Vendor shall disclose to the Auctioneer any medication or drug administered to a Lot at any time during the 7 days prior to the Sale. The Auctioneers may request at any time prior to the Sale a blood and/or urine sample from any horse to be analysed for drugs by qualified persons. If any of the tests shall find the existence of drugs which have not been disclosed, and if in the opinion of the qualified persons the presence of the drug is material and/or masks defects in the horse the Auctioneers shall have the right to withdraw the lot or cancel the Sale.
19. The Vendor warrants that full and complete disclosure will be made to the Auctioneer by way of veterinary certificate as to whether any Lot has undergone invasive joint surgery, surgery to repair a fracture, surgical intervention of the upper respiratory tract, or has undergone abdominal surgery.
20. Should the payment of proceeds be disputed by any party, the Auctioneer may at its discretion withhold payment until the dispute is resolved.
21. Under the Health and Safety at Work Act 2016 the Vendor/Preparer agrees to take all practicable steps to ensure its employees are adequately trained and to ensure the safety and supervision of its employees or other persons in the vicinity at all times.
